27 Mr. Malachowski reviewed the Renewal Rate Summary for January 1, 2020 handout. He noted that the
28 medical coverage with BCBSIL has a +4.5% increase (2.4% + 2.1% ACA). The Dental Plans, Life (Basic and
29 Voluntary), Vision, Cancer and Accident Plans do not have any rate changes for the year 2020. BPC has
30 increased the Flex Plan by .10 cents or from \$3.90 to \$4.00 per employee.
