30     Mr. Malachowski reviewed the Monthly Paid Premium vs. Monthly Paid Claims summary for  
31     1/1/2018 thru 5/31/2022, the Membership Info summary from 1/1/2018 thru 5/31/2022, and  
32     the Key Indicator summary. He noted that the proposed medical coverage with BCBSIL has a  
33     +41.10% increase. The Dental Plans for Year 1 and Year 2 at 0% increase, Life Basic and  
34     Voluntary a guarantee thru 12/31/2023 at 0% increase, Vision (Year 3 of another 4 year rate) at  
35     0% increase, the Cancer and Accident Plans have 0% increase, and BPC a 0% rate guarantee thru  
36     12/31/2023.
