RESOLUTION NO. 2026-174

RESOLUTION CALLING FOR THE RESIGNATION OF THE CHAMPAIGN
COUNTY CLERK

WHEREAS, the Champaign County Clerk serves as the chief election authority and keeper of vital public records, a position demanding absolute public trust, transparency, and integrity; and

WHEREAS, current Champaign County Clerk Aaron Ammons has been indicted by a federal grand jury on criminal charges, including federal obstruction of justice; and

WHEREAS, these severe criminal allegations compromise the perceived impartiality of the Clerk's Office, threatening public confidence in the administration of upcoming local and federal elections; and

WHEREAS, the residents of Champaign County deserve a fully functioning government led by officials who are unburdened by severe criminal litigation and entirely focused on public service; and

NOW, THEREFORE, BE IT RESOLVED by the County Board of Champaign County, Illinois, that this body officially calls upon Aaron Ammons to immediately step down from his position as Champaign County Clerk to allow the office to function without the distraction of federal criminal proceedings.

BE IT FURTHER RESOLVED that a copy of this resolution be formally delivered to the office of the Champaign County Clerk and shared openly with the citizens of Champaign County.
