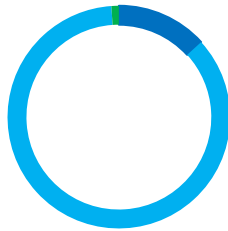

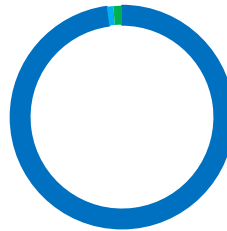
Information Dissemination to Champaign County

CCEMA had **15,558 views** of its social media content and gained an additional **559 new followers**.

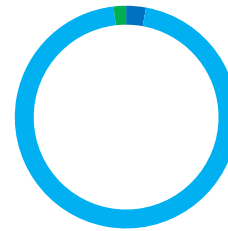
Post Views
