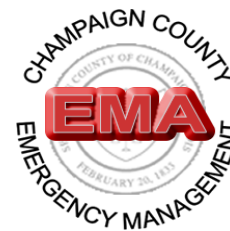

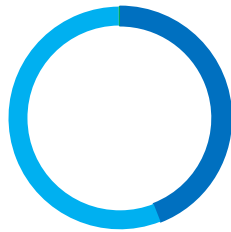

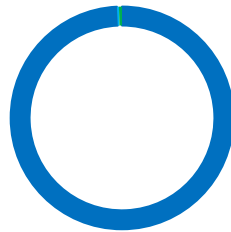
Information Dissemination to Champaign County

CCEMA had **35,359 views** of its social media content and gained an additional **525 new followers**.

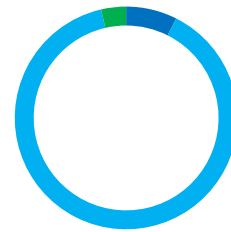
Post Views
