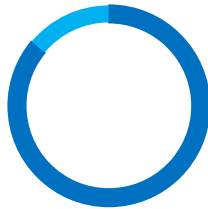

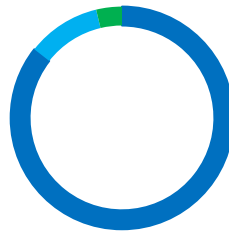
Information Dissemination to Champaign County

CCEMA had **122,191 views** of its social media content and gained an additional **411 new followers**.

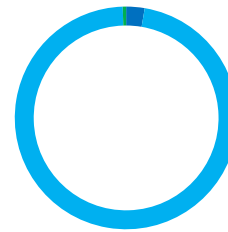
