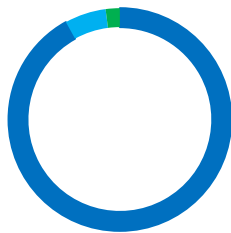

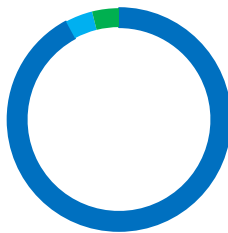

CCEMA had **187,485 views** of its social media content and gained an additional 452 **new followers**.

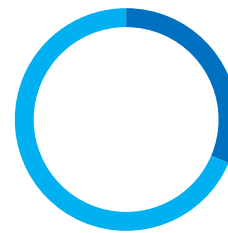
