Having agencies, participate, or be partners in the process, and really helping to inform what their needs are, and then the empowerment component is so that they now have the skills that they can do it by themselves over time, and can do it in-house, rather than having to externally outsource evaluation activities.

As we were developing them, to find out, is it hitting the right tone? Is it, um... not necessarily too much of a 30,000-foot view, or not in the weeds, so we're making sure that we're tailoring it based on the needs of the different agencies.

Trainings and resources, so that capacity building in terms of the materials that we were developing based on agency-driven needs from the needs assessments, as well as from the working group.

And then having that open communication and informal support, so consistent communication about our progress, what we were planning for in terms of future activities, and then the availability for questions if anybody has those at any time. So not just the agencies and programs that we were providing technical assistance for.

If others wanted to have conversations with us, ask us a quick question, we made ourselves available for that as well So to go a little bit more into our technical assistance, we had four programs identified to have the greater support. We improved their understanding based on topics that they thought were important, which included logic models.

So, who doesn't love a logic model? Um, right? And we tried to present it in ways that Won't make people cry. So, um, and we'll give you an example of that later, which was a direct quote from the needs assessment, so, you know, we're aiming to, uh, you know.

Meet the needs. Survey development, so some of the programs wanted help with developing a survey, survey administration, as well as learning about online systems and administrating it.

And so the effect was that, um, we gave a survey out to the agencies and programs that we served.

00:30:51.880 --> 00:31:04.880 Data collection tools were developed, uh, data collection management, um, was, was... Um, also addressed in terms of efficiency and different systems that they could use to manage their own data.

And one of the survey respondents said that collaboration was strong, they appreciated the reciprocal input, which was reflected in the final outcome of the survey tool, so demonstrating that we really worked with them.
