<p>Case Synopsis: In the early morning hours of 10/02/24, Champaign County deputies were dispatched to a business alarm in the 3900 block of S Duncan Rd in Champaign. Upon arrival, deputies located six college-aged males trespassing on the business property. Items and merchandise from the business were later located in the offender's vehicles. All 6 individuals were ultimately each issued NTA's for trespassing and theft. The President of the business later informed the deputies that the offenders had taken approximately \$1776 worth of merchandise, which included the cost of damaged property. The President of the business also informed deputies of 3 additional offenders that were not located on scene, based off video surveillance footage on the property. Those 3 suspects have not been located nor interviewed at this time.</p>
