Case Synopsis: On 12-19-2024 at approximately 2043 hours, Deputies were dispatched to the 2400 block of East Illinois Street in Urbana for the report of a domestic incident that was actively occurring inside a residence. While enroute METCAD advised deputies that the reporting party was being uncooperative and was not providing information other than the wife was harassing the reporting party and was attempting to take the reporting party's dog. When deputies arrived too the residence both parties were verbal but separated. Interviews were conducted and due to conflicting statements and one party agreeing to leave the residence for the night a physical arrest was not made. Deputies stood-by with both parties while the female party packed items to leave. Deputies cleared the scene without incident after the female party had left the residence.
