Summary

The monthly IEMA, local emergency radio and siren tests were conducted. The EMA liaison group did not meet this month for upcoming events and for community awareness; we will have one for both November and December. EMA attended the monthly Fire Chief's Association meeting. EMA hosted the monthly Public Information Officers meeting. EMA provided support to the Village of Gifford and outlying areas due to storm and tornado damages throughout the county on multiple levels.

Gifford Tornado Response and Recovery Efforts

- Provided monitoring of the potential storm situation on Nov 16 continuing through the event
- Provided 24 hour onsite personnel and mobile command post to response and recovery efforts from onset of the event (Nov 17) to the evening of Nov 22
- Provided two generators to support water system damaged from the tornado
- Assisted in the timely determination of the extent of damages in Gifford and development of the initial damage assessment reports to the state
- Compiled submitted paperwork on behalf of the county for individual assessments for damages regarding private property
- Compiled and submitted paperwork on behalf of the county for public assistance for services and cost associated with response and recovery efforts from storm and tornado damages
- Assisted in coordinating IEMA, FEMA requirements with Gifford and other communities.
- Facilitated support by non-government agencies (American Red Cross, Salvation Army, United Way, St. Paul Lutheran Church and others) to support immediate and on-going recovery efforts
- Still providing to support to Gifford and other areas of the county for FEMA and other disaster assistance
