The County EOC also established a PPE reserve that is stored at CUPHD in case of emergency. This is a 90-day stock to support first responders and the hospitals in case of resurgence.

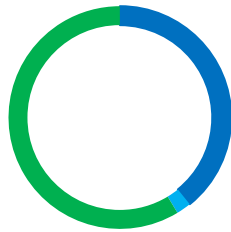

- Attended IL Volunteer Organizations Active in Disasters (VOAD) quarterly meeting—Nov 30<sup>th</sup>

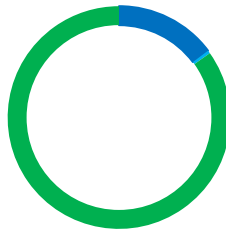
Information Dissemination to Champaign County

CCEMA had **16,505 views** of its social media content and gained an additional **19 new followers**.

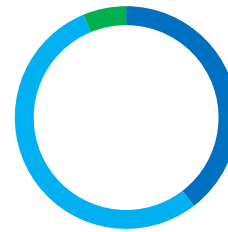
Post Views
