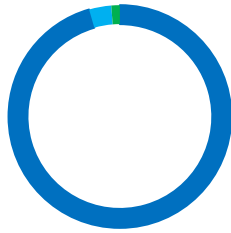

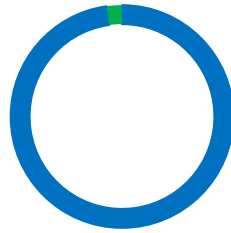
Information Dissemination to Champaign County

CCEMA had **97,200 views** of its social media content and gained an additional **304 new followers**.

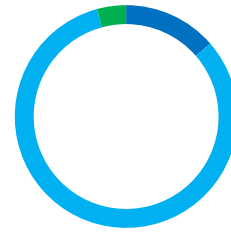
