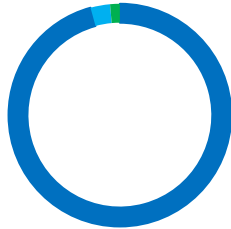

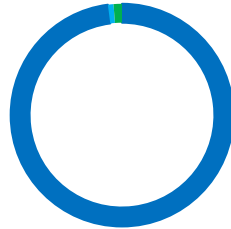

CCEMA had **114,291 views** of its social media content and gained an additional **371 new followers**.

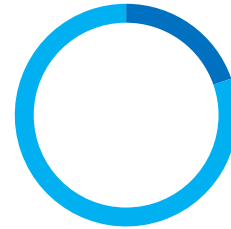
