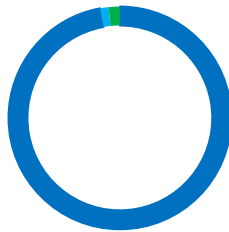

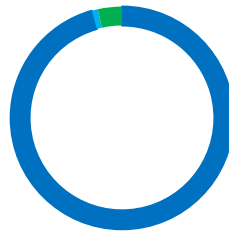
Information Dissemination to Champaign County

CCEMA had **111,556 views** of its social media content and gained an additional 362 **new followers**.

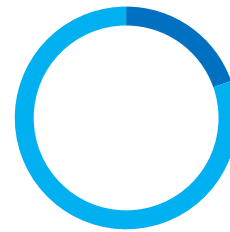
