Property in these Townships, other than farmland and coal, is to be assessed at a 33.33% median level of assessment, based on the fair cash value of the property. You may check the accuracy of your

assessment by dividing your assessment by the median level of assessment. The resulting value should equal the estimated fair cash value of your property. If the resulting value is greater than the estimated fair cash value of your property, you may be over-assessed. If the resulting value is less than the fair cash value of your property, you may be under-assessed. You may appeal your assessment to the Board of Review.

If you believe your property's fair cash value is incorrect or that the equalized assessed value is not uniform with other comparable properties in the same neighborhood, the following steps should be taken:

1. Contact your township assessor's office to review the assessment.
2. If not satisfied with the assessor's review, taxpayers may file a complaint with the Champaign County Board of Review, call 217-384-3758 or visit www.co.champaign.il.us/boardofreview/boardofreview.php for more information.
3. The final filing deadline for your township is September 11, 2023. For more information on complaint deadlines, call 217-384-3758 or visit www.co.champaign.il.us/boardofreview/boardofreview.php.

Your property may be eligible for homestead exemptions, which can reduce your property's taxable assessment. For more information on homestead exemptions, call 217-384-3760 or visit www.co.champaign.il.us/ccao/exemptions.php.

Your property tax bill will be calculated as follows:

$$\begin{aligned} \text{Final Equalized Value} - \text{Exemptions} &= \text{Taxable Assessment} \\ \text{Taxable Assessment} \times \text{Current Tax Rate} &= \text{Total Tax Bill} \end{aligned}$$

All equalized assessed valuations are subject to further equalization and revision by the Champaign County Board of Review as well as equalization by the Illinois Department of Revenue.

Only parcels that have changed by other than the equalization factor or farmland that changed by other than the certified farmland values are published in non-quadrennial years.
