Case Synopsis: On September 21, 2025, at approximately 0350 hours, Deputies were dispatched to the 400 block of North Main Street in Saint Joseph for the report of two males fighting in the middle of the street next to a vehicle. When deputies arrived at the scene the males had stopped fighting and were separated to begin conducting interviews. A deputy recognized the males from a prior traffic stop approximately 3 hours prior. At approximately 0030 hours the deputy had stopped the males leaving a bar for a traffic infraction. At the time of the stop the deputy did not see enough signs of impairment to further a DUI investigation. When the males were separated following the apparent physical altercation, deputies began conducting interviews of the males. A deputy interviewing one of the male subjects observed signs of impairment from the driver of the vehicle. Following the interview regarding the altercation and DUI investigation began.
